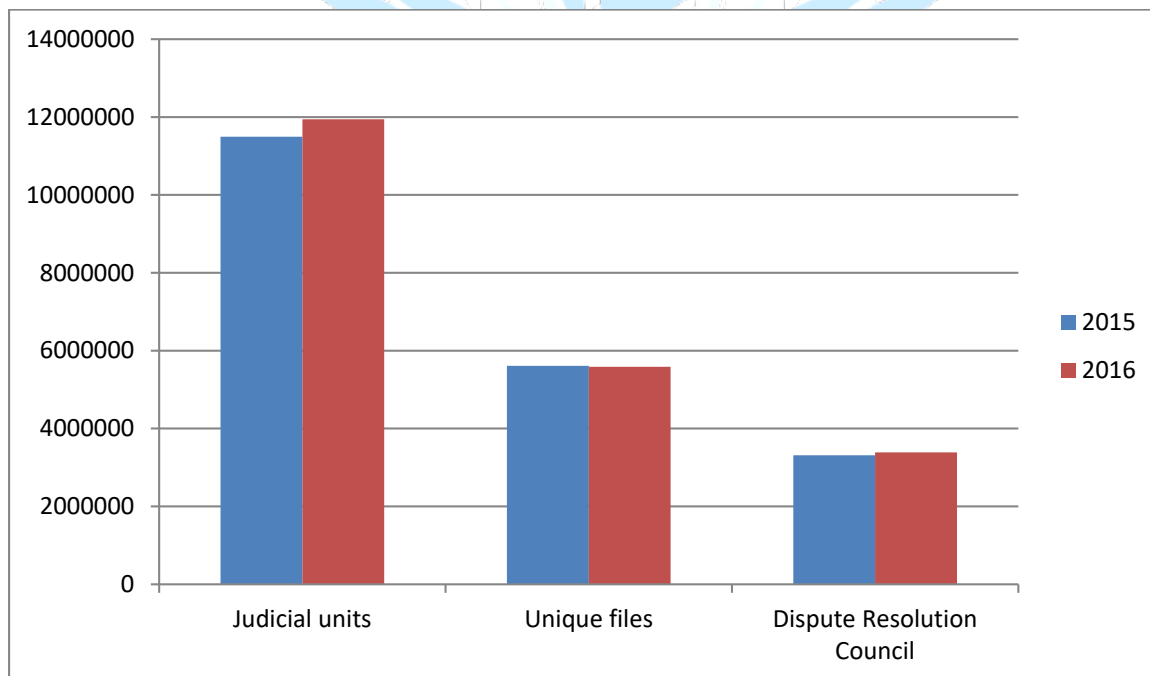

The General Inspection Organization of Iran (GIO)

The General Inspection Organization of Iran (GIO) to institutionalize public participation and public supervision has taken important steps to communicate with people in order to handle their complaints from executive agencies on the misuse of administrative and receive timely reports, so that in 1996, it set up a news headquarters with a contact number of 136. In order to facilitate people's access to the organization and provide electronic services to clients, the center 136 has worked on modern and digital facilities over the past few years. This center, while solving the

problems of individuals to review and refine public reports referred important cases to specialized agencies for monitoring and inspection.
